Dennis C. Brewer, aged 87, passed away peacefully in his sleep on October 30, 2024. He was born at home on December 18, 1936, in Perryville, Missouri to Edward Louis and Stella Ann (Bass) Brewer, he died in the same home. Dennis attended St. Vincent's College and the University of Missouri, Columbia. He worked as an attorney in Perryville for 46 years, serving as Perry County Prosecuting Attorney before establishing his own law practice. In 1999 he was joined by his son Craig to form the Brewer Law Firm.

Dennis was known for his charm, mild demeanor, dance moves, and dry sense of humor. He was a great storyteller and fancied himself an excellent card player. He also maintained a repertoire of poetry and songs and was inclined to perform at any given opportunity. Charged with a generous spirit, he was always ready to help anyone in need.

Dennis was preceded in death by his parents, his wife Judith (née Klump) and is survived by children Craig

(Lauren), Denise, and Diane; grandchildren Grace, Kate, and Max; and sisters Sr. Helen Brewer, DC, and Victoria Elliott.
